Dr. Lyles distributed and reviewed with the board the Report of the CEO:

1) **Construction** – A temporary fence and driveway have been installed at the construction site. Demolition of the exterior stairs and ramp has been completed. Exterior stucco has been removed from two sides of the existing building, where the new building will connect. All mechanical equipment, fans and exhausts have been disconnected. PGW has rerouted the gas lines and connected the new service. Excavation of the site has been completed and footers are being laid. In approximately five weeks, work on the stairwell and steel structure will begin. Regular construction meetings will be held on alternate Tuesdays at 2:00 PM. The next meeting will take place on Tuesday the 18th by zoom. Please let me know if you are interested in attending.

### 2) School Advocacy

- a. I attended the Philadelphia school board meeting on March 23<sup>rd</sup>. Forty charter school representatives attended as well to 1) update the board on the positive impact of charters and 2) to petition for charters to be granted more seats e.g., GLA's request for a high school.
- b. PCE and AACSC have held weekly meetings which I attend virtually. Both groups are addressing the need for more consistent communication from the charter sector to Harrisburg and local officials.
- c. I will attend a rally at City hall on April 20<sup>th</sup> where PCE will present the City Council with a petition of 2300+ signatures requesting their support for charters.

#### 3) 2023-24 Enrollment

- a. There are 2994 students on the waiting list as of this week.
- b. Ninety-nine (99) seats have been filled; seventy-four (74) kindergarten, including siblings, and twenty-five (25) upper grade siblings.
